national Day Celebration on September 13th. This event takes place downtown just like the Festival in June. The race will happen at 2:30 pm. Please make sure as you sell the leases to mark the new date on the lease you give to the purchaser.

So for now, you may want to hold off on selling duck leases until after July 4, when we can actually sell in person. If you have already sold some, please let me know and we can get the money deposited and let the purchaser know the situation.

County Fair, July 16-20....

Some minor changes for the county fair book rules/schedule. The Fair Book will be posted soon on our website.

- \Rightarrow Judging of Sheep and Goats will both be held on the same night of Saturday, July 18
- ⇒ Poultry/Rabbits check in time has been changed to 7:30-10 am (same as all projects). Judging will be on Friday, July 17 starting at 11:30 am
- \Rightarrow No rate of gain for sheep, goats, and swine this year.
- \Rightarrow No pen of 3 classes for livestock.
- ⇒ Remember, Sheep and Goats can be braced, but must be shown with all four feet on the ground. Prior to the class starting, members will be reminding of the rule. If caught breaking this rule, participant will be dropped to the bottom of the class, a second infraction may result in a disqualification.
- ⇒ This year due to several reasons, Grand Champion winners will be receiving a monetary award and ribbon instead of a trophy and ribbon. These awards will still be sponsored by local individuals or businesses and will require a thank you.
- \Rightarrow All judging, activities and schedule may change due to COVID-19 at time of Fair.

VOLUNTEERS NEEDED...FAIR SUPERINTENDENTS

What is a SUPERINTENDENT? A Superintendent is someone who assists judges during entry day on July 18th. They also assist in creating the display for the project area. We encourage Livestock Superintendents to assist with their respective livestock weigh-in and out in the ring during the show. These are great leadership activities for your record book!

CHILDREN CARING FOR CHILDREN: NEW PROGRAM WILL HELP

K-State Research and Extension has launched a new program, "<u>Suddenly in Charge</u>," aimed at helping older children learn the best ways to handle what in some cases is a new role taking care of younger children, whether in their own homes or those of a neighbor or friend.

"Suddenly in Charge is important for our Kansas communities because many families are trying to work from home, and/or have children now at home responsible for providing care for younger children," said Bradford Wiles, an extension specialist in early childhood development. "The safety of these children is crucial and we want to help families get some of the basic safety elements in place first, and then help them with ageappropriate activities."

Helpful information is available on the Suddenly in Charge <u>website</u> for teens, tweens and anyone charged with caring for younger children, whether it's a new situation or they've been doing it for years.

Suddenly in Charge will provide trusted guidance from experts with information about the things that families need. For example, resources about food, media safety, disaster safety, animal care and safety, and mental health and wellness, just to name a few.

One of the first resources is a babysitter information sheet with spaces for parent contact information, other emergency contacts, doctor information and more.

Horse Level Testing

Horse Level Testing is still required to participate in State shows. Due to COVID-19 policies, all components will be moved to an online format. The deadline for completion of Level testing is July 15th. (This is a state deadline and must be followed.) There will be a \$10 fee. Complete instructions, coversheets and leadership sections are available on the 4-H section of the Ford County website at www.ford.ksu.edu. Some of the leadership sections have been expanded to make it easier for members to complete. Each level of the exam contains 50 question and must be completed online in one sitting.
